\*Half day kindergarten does NOT affect the tuition of siblings in Grades 1 through 8. In other words, a half day kindergarten student does NOT count as a “first child” for families with more than one student.

After school starts, changes from half day kindergarten to full day may occur at the trimester breaks and are billed accordingly.

### PARISHIONER STATUS 2009-2010

A Parishioner Tuition Rate is available to full time Annunciation parishioners who have been formally registered in the Parish as of April 1, 2009 and meet the following criteria:

1. **Time:** Attends Sunday Mass at Annunciation Catholic Church on a routine, regular and on-going basis.
2. **Treasure:** Recognizes the financial obligation and responsibility to the parish by participating in the Stewardship Program (weekly envelopes).
3. **Talent:** Actively participates in Annunciation Parish and School activities and ministries

### CALCULATING YOUR TOTAL FAMILY TUITION: EXAMPLES

Case 1: In-parish family with one 6<sup>th</sup> grader, one 3<sup>rd</sup> grader and one half day kindergartner: first child tuition = \$3,770; second child tuition = \$3,420; half day kindergarten tuition = \$2,730; total tuition = \$9,920.

Case 2: In-parish family with one 5<sup>th</sup> grader and one full day kindergartner: full day kindergarten = \$3,970; second child tuition = \$3,420; total tuition = \$7,390.

Case 3: Out-of-parish family with one 2<sup>nd</sup> grader and one half day kindergartner: first child tuition = \$5,545; kindergarten tuition = \$4,170; total tuition = \$9,715.

### FUNDRAISING COMMITMENT 2009/2010 SCHOOL YEAR

In addition to tuition, there is an **obligation** for fundraising support of the school in the amount of \$100 per child. This is an obligation. It is not optional, and is due by November 1, 2009. This amount may be raised in the form of tax deductible contributions in connection with the school-sponsored event know as the **Marathon**. The Marathon bike ride begins at school at 9:00 a.m. on Saturday September 19<sup>th</sup> and continues down to and around Lake Harriet. In the event that a family does not meet this obligation via fundraising the family will be billed. The Marathon Fee cannot be made through FACTS.
