III. General Reports 6:35-7:15 pm

- Principal's Report
 - Dean of Students search is progressing with several experienced applicants.
 - With a couple of recent non-teaching staff departures, the school and parish are working together to determine where to adjust roles to fill in gaps/meet needs; changes to responsibilities are not expected to significantly impact teaching staff.
 - Staff are discerning some narrow changes to uniform expectations what is considered compliant and what isn't (e.g., branded or sport-themed items). Open to parent involvement if anyone feels strongly – note that the intent is not to make

families purchase new wardrobes. APO offered support in determining what we currently have in-house to offer students that may need modifications.

- Administration is looking to impart greater clarity and transparency into the financial aid award process. This includes evaluating how awards are calculated and factoring in additional considerations and circumstances. Loss of institutional knowledge regarding prior processes creates and opportunity to re-evaluate the FA process to ensure it's equitable and appropriate in meeting needs.
- Church Updates
 - Briefly reviewed Holy Week schedule and April 11 fish fry
 - Father Zehren will be living on-site in the rectory beginning this summer. Updates to the building are underway and tours will be offered next month.
- APO updates
 - Recap of recent fundraising event including the Evereve sale (brining in approximately \$800) and used uniform sale.
 - APO has been able to issue micro-grants recently, including for microphones for Shrek Jr, The Musical
 - School staff are still receiving one APO-sponsored lunch each month along with one APO-sponsored treat each month.
- Enrollment, Marketing, and Health updates
 - Enrollment is generally on track to meet or slightly exceed targets for the 25/26 school year.
